Thank you for your email of 21 April 2023 to Environmental Standards Scotland (ESS) requesting information under the Freedom of Information (Scotland) Act 2002. The information which you request is as follows:

Requesting details of

1. The subject matter of the 12 closed cases referred to in response reference ESS.FOI.006, and the dates from referral to closure by ESS of those cases.

For reference, the question and associated response from ESS.FOI.006 relating to the request above are set out below:

Request - any action taken since your creation whereby citizens may have been referred to another organisation rather than ESS.

Response - of the 59 cases opened since the creation of ESS, 12 have been closed on account of the concerns falling under the responsibility of another oversight body. In these cases, the applicant was referred to the relevant oversight body.

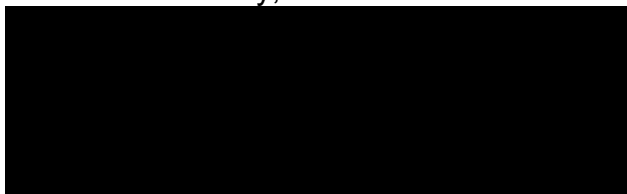
